1. Chief Executive Officer: 01 Post

Consolidated Pay: Rs. 1,20,000/- per month.

Essential Qualification:

- First Class B E/B Tech in Agricultural/Food/Mechanical/Chemical Engineering from recognised Universities/Institute of repute with good track record.
- Master's in Business Administration (MBA) or PG Diploma of 02 years duration in Agri Business/ Rural Development/ Operations/ Technology Commercialization from recognised Universities/institute of repute with good track record.

Essential Experience : Minimum 3 years' of working experience in Agri business sector / accelerator program in Level -11 of Pay matrix or equivalent salary.

<u>Desirable</u>: Experience in business mentoring with start up companies and knowledge in Intellectual Property. Good verbal and written communication skills. Strong command in computing, word-processing, data management and internet skills. Analytical skills, Leadership and Team player qualities are desirable.

Maximum age limit: Not exceeding 40 years.

- 5. The appointment will be purely on Contract basis initially for one (1) year which can be renewed up to five (5) years based on the evaluation of satisfactory performance or termination of the Project whichever is earlier.
- 6. Candidates applying for more than one post should apply separately for each post.
- 7. Candidates should submit their SC/ST/OBCs/EWS/Disability Certificate issued by the Competent Authority in the prescribed format along with the application form, in support of their claim.
- 8. Degree as referred above should have been awarded by a recognized University/Institute.
- 9. The candidate applying for any post should ensure that he/she fulfils the eligibility criteria for the post. His/Her admission to any stage of the selection process will be purely provisional subject to confirmation that he/she satisfies the prescribed eligibility criteria.
- 10. Mere eligibility will not vest any right on any candidate for being called for Written/Trade Test/Interview. The decision of the Institute in all matters will be final. No correspondence will be entertained from the candidates in connection with the process of selection. Canvassing in any manner would entail disqualification of the candidature.
- 11. Persons employed in Government / Semi Government Organizations / Autonomous Bodies should submit their application through proper channel. They may, however, send an advance copy of the application. Those who are unable to process their application through proper channel may submit 'No Objection Certificate (NOC)' from present employer at the time of Written/Trade Test/Interview. However, they should submit an undertaking to that effect. Direct application from such candidates will not be entertained.
- 12. Candidate should submit a certificate from the employer/competent authority that no vigilance/disciplinary case is either pending or contemplated against him/her.
- 13. The Institute shall verify the antecedents/documents submitted by the candidate at the time of appointment or during the tenure of the service.
